I. Please listen to this chapter twice.

It is an Old Testament favorite. Ask most people what some of their favorite Old Testament stories are, and "Daniel in the lion's den" will often be in the top ten. This may be a very familiar story but if you pay close attention, you will glean new truths from its depths.

2. Read Daniel 5:30-31 to refresh your memory.

In what way have things changed for all those who living in Babylon?

3. In the first chapter of this book, Daniel was a young man taken into captivity. He was probably no more than I5 years old. He served under two important Babylonian kings while he was captive.

Who were the two kings?

Daniel I:I	the years of his reign were 605 – 553 BC.
Daniel 5:I	the years of his reign were 553 – 539 BC.
Approximately, how old would Daniel be at	the opening of this chapter?

4. As Daniel 6:I begins, Darius is the new ruler over the kingdom of Babylon. He is not a young ruler; he is in his early 60s. He has had many life experiences.

Like any new regime or government, Darius begins lining up his staff. He appoints ______ satraps to rule throughout the kingdom. Satraps are very similar to a prince or governor who would help govern the people. What do you learn about Daniel in verse I-3?

- 5. The text does not tell us how he distinguished himself during this time, but once again God's favor is on him. Daniel is one of the three key rulers under Darius and over all the satraps.

 According to verse 3, what position is he about to have bestowed on him?
- 6. Daniel distinguished himself by serving to the best of his God-given abilities every day, with no grumbling or complaining about being in captivity under a pagan ruler and no disgruntled attitude or slacking because of discontentment. Who was the focus of Daniel's service?
- 7. Not everyone in the kingdom is happy to hear Daniel is fairing so well under this new ruler.

 When word gets out that he is about to be promoted, what is the consensus among the other leaders?

What words would describe the feelings of the satraps?

8. Great authority often comes with great jealousies; this is no exception. Daniel is no longer a young man. He has experienced jealousy many times and knows exactly how to handle it.

What is your track record with jealousy?

How do you respond when someone is against you for no good reason?

Think of the last time you experienced jealousy. How did you handle it?

9. The satraps might have been jealous of anyone the King would choose to place over them. What is one possible reason for their jealousy toward Daniel?

Is he a Persian?

Is he a Babylonian?

What is his nationality?

Why is Daniel in this kingdom?



10. Jealousy is a very common response when we see someone elevated to a position of authority and we do not feel they were qualified. Think of the last political leader elected who was not a man you voted for; how did you feel about being under their rule?

You may not have actually worked under them, but you were under their authority. What words filled your conversations while they were in that office? (you need not write an answer just remember)

Did you still carry out your work each day like Daniel did?

Did you have the attitude that God is sovereign in the affairs of the earth?

Regardless of your opinion of our leaders, what does Paul urge us to do in I Timothy 2:I-2?

- 24. Daniel was a man who had good habits. He worked hard without grumbling or complaining. He worshiped faithfully, despite adverse surroundings. What good spiritual habits do you have in your life?

 watch your habits, they become your character;
 watch your character, it becomes your destiny."

At the first light of dawn, we see the King rush to the lion's den. What did the king say?



- 41. Did you notice that even this heathen king acknowledged Daniel's testimony? What did he call Daniel?
- 42. Daniel answered the King with such respect. I thought this was an amazing response, considering his current situation. One might expect someone down in that pit to say, "Yes! Now get me out of here!!!" Daniel does not say anything like that. He even takes time to explain the events of the night. What did he say had happened in the lion's den on that night?
- 43. Finally, the King gives the order to drop a rope and pull Daniel out. What happened to the men who had falsely accused Daniel and sealed the opening with their signet ring (Dan 6:17, 24)?

One of the many lessons from this chain of events is to think before signing your name in agreement.

- 44. I have heard people comment on this story and say, "I bet the lions had already eaten and so they just weren't hungry." How do we know that was not the case? (vs. 24)
- 45. Can you think of a time God has protected you, or someone you love, from an injustice?

Our God will protect us but that does not mean we will not experience very difficult situations. Please share with your group a time you were protected by God, without giving names or too many details. There will be times when God's protection may go unseen. God's protection may lead us on a path away from disaster. The next time you don't get what you want, or you find yourself stuck at a railroad crossing waiting for the train to pass, or at a traffic light, instead of getting upset, let's consider it could be God's divine protection helping us avoid something farther down the road. Why not thank him for his protection?

- 46. Read I Peter 2:20, which speaks to suffering an injustice.

 Think back to the last time you thought or said the words, "That's not fair."

 How did you handle the injustice you were experiencing?
- 47. Have you experienced divine favor like Daniel did?

If you have placed your faith in the Lord Jesus Christ, then you are a child of the King! However, this must be followed by a life of humility.
